In levels 0 through 3,

*** Standard Safety Protocols include:**

- Frequent Disinfecting / Cleaning
- Social Distancing
- Face Coverings Required, with Specified Exceptions
- Sick Individuals Stay Home
- Best Practices for Seating in Classrooms
- Physical Modification to Buildings
- Testing as Needed / Contact Tracing and Self-Isolating As Required
- More Extensive Screening of Residence Hall Students

Level 2

Physical Modifications include:

- Air Purification
- Hand Sanitizing Stations
- Social Distancing Reminders / Positional Directives
- Clear Barriers Upon Request
